Capital Campaign to Fund Building Renovations

During 2015 the Capital Campaign committee worked diligently to continue to raise \$1.8 million for the Willard renovation project. The committee was active conducting personal asks and writing grants.

The renovation project will expand the building, provide better security, improve energy efficiency, add a fire alarm and sprinkler system, replace the roof and add parking.

This renovation will allow Willard to expand child care services, provide better handicap accessibility, offer larger rooms for meeting space, family gatherings and youth activities, and offer additional programs and enhanced community services.

Funding that was secured or pledged in 2015 totaled \$695,972. This funding has been donated by businesses, foundations, and individuals. To date we have raised \$975,000.

This is the community we serve:

Willard Community Center primarily serves the southwest quadrant of Lincoln, Nebraska. The neighborhood has a population of 8,222, with a per capita income of \$24,123, which is 13% less than the city average. Twenty three percent of the population is younger than 14.

This is how we make an impact:

We provide licensed child care for preschool, pre-kindergarten, the Roper Elementary Before and After School program, Lakeview Community Learning Center Before and After School Program and the teen before and after school program at Willard. See the statistics of these programs below.

321 unduplicated children enrolled in all of our licensed child care programs listed above

92 children (29%) were ethnically diverse

59 children (18%) lived with a single parent on a single parent income 117 children (36%) received free and reduced lunches from school

64 children (20%) received Title XX assistance

24 children were on a waiting list all year

Program Highlights from 2014-15 School Year

Preschool

 18 advanced on to Pre-K or Head Start, 4 who had just turned age 4 returned to complete another year.

Pre-K

 20 of 21 advanced to kindergarten and one, on the request of parents, stayed to gain maturity.

Elementary Before and After School Programs

- * Children at Roper were asked what they liked the most about the before and after school program. They consistently said the staff, snacks, and spending time with friends.
- According to the CLC Snapshot, the Lakeview CLC students scored higher on the NeSA (Nebraska State Accountability) test than the rest of the school.
- * 46% or 151 students of Lakeview Elementary participated in the CLC 30 + days. (76 in the daily core program, 75 participated in after school clubs)

Teen Program

- The students maintained a group grade point average of 86.9 or a B+ average.
- 848 safe rides to school field trips and special events throughout the year were provided.
- With a guaranteed ride to and from school, the students attend every day and participate in after school sports and clubs.

Program Information



<u>Preschool for 3-4 year olds</u> held at the Center focuses on letter and number recognition, shapes, colors, cognitive and fine motor skills, and language skills. Activities include math, science, library, dramatic play, and many educational learning activities. Twenty two children participated.

<u>Pre-K for 4-5 years olds</u> held at 1030 West "Q" Street has a curriculum that focuses on developing skills that prepare them for kindergarten. Daily activities and weekly themes encourage

multi-cultural awareness and parent involvement. Learning centers include math, science, language, literacy, blocks, and dramatic play. Twenty one children participated.

Roper Elementary Before and After School Program held at 2323 S. Coddington Street runs from 6:30 am to the start of the school day and resumes after school until 6:00 pm. This program offers a healthy snack after school and a wide variety of activities, ranging from daily scheduled events to large group games and homework time. This program includes child care when school is not in session. Unduplicated count for this program was 169 children with 15 children on a waiting list.





Lakeview Community Learning Center Before and After School Program held at 300 Capitol Beach Blvd. runs from 6:30 am to the start of the school day and resumes after school until 6:00 pm. Willard is the lead agency for this CLC and receives additional funding from the 21st Century Community Learning Centers Grant Program to support academic enrichment opportunities as well as additional activities designed to complement the school's academic program. After school clubs are offered to all students in the school at no charge. Unduplicated number of children in the core before and after school program was 76.

Teen Before and After School Program for Park Middle School Students held at the Center provides a structured, supervised and safe environment for middle school youth. Open from 6:30 am to the start of the school day and resumes after school until 6:00 pm. This program provides transportation to and from Park Middle School. Our neighborhood based program is deeply committed to improving the teens' academic performance while also building key leadership skills through various activities, community improvement projects and positive relationships. This program receives funding support from United Way and the Kenny Gardner "It Was Fun" Memorial Golf Tournament.





<u>Summer Program</u> held at the Center is open M-F from 6:30 am to 6:00 pm. The children are placed in age appropriate groups (Preschool, K-1st, 2nd-3rd and 4th-8th grades) and participate in weekly fun themed and educationally based activities. The children go swimming and on a field trip every week. A total of 147 children, preschool through 8th grade were enrolled for the summer.

<u>Adult Programs</u> held at the Center includes low impact aerobics, licensed bingo, monthly pot luck lunches, and a variety of hobby and club groups.






